OFFICE ORDER

In pursuance of tender No. CREST/EOI/2016-17/4 published on dated: 26.12.2016 for invitation of expression of interest for empanelment of manufacturers/ system integrators for rooftop grid connected SPV Power Plants in Chandigarh, 14 Nos. bidders are hereby empanelled by CREST for installation of SPV Power Plants in U.T., Chandigarh for 1 kWp to upto 100 kWp w.e.f. 01.04.2017. Residential, institutional and social sector of Chandigarh interested to install SPV Power Plants and want to avail subsidy from MNRE, GOI through CREST, can install SPV Power Plants from any one of empanelled agencies of CREST. But, the 30% subsidy for the same shall be released to the consumer / applicant, after commissioning of the project and receipt from MNRE, GOI on the basis of L-1 rates of different categories arrived through this e-tendering, which are follows w.e.f. 01.04.2017, or as decided by Ministry of New & Renewable Energy, Govt. of India, time to time, whichever is lower.

The above said L-1 rates for different categories will be applicable w.e.f. 01.04.2017. The details of empanelled agencies of CREST alongwith their rates quoted for different categories for installation of SPV Power Plants in Chandigarh are enclosed as Annexure-I for further facilitation of general public of Chandigarh for installation of SPV Power Plants.

After the installation and commissioning of SPV Power Plant, the applicant is advised to inform CREST for its verification. The verification report alongwith joint commissioning report shall be forwarded to MNRE, GOI for release of subsidy. The subsidy as and when received from MNRE, GOI shall be released to applicant by CREST.

Any agency found violating MNRE guidelines and terms & conditions of DNIT for Expression of Interest for Empanelment shall be liable for delisting from the empanelled list of CREST.
